

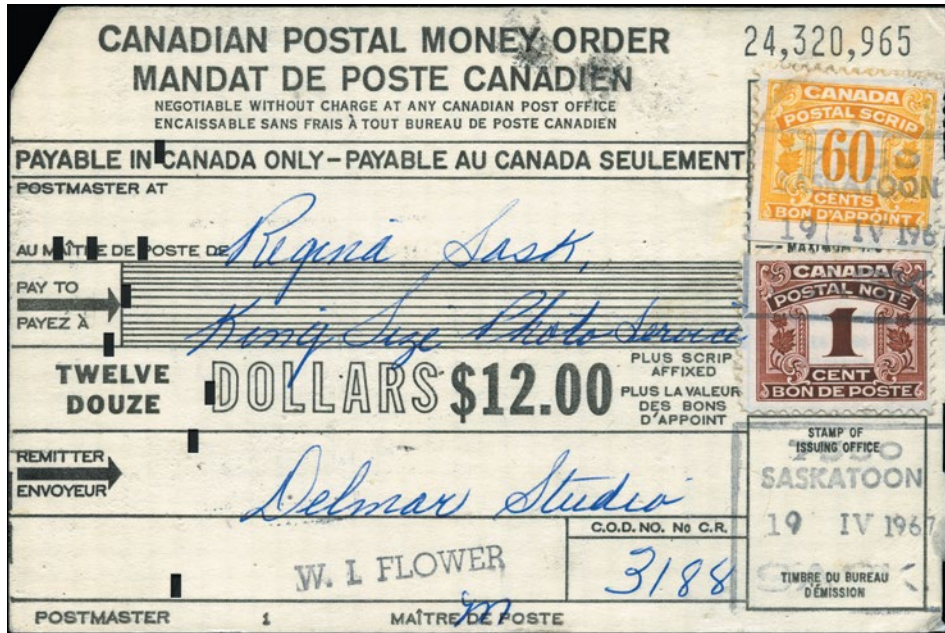

Several values of this issue exist with a roulette perforation along one of the vertical sides. These are scarce. Shown is a 10¢ value on piece and a 50¢ value on document. Bileski has surmised that the printer used a roulette perforation in order to separate stamps that had been produced imperforate between, but this is very unlikely.

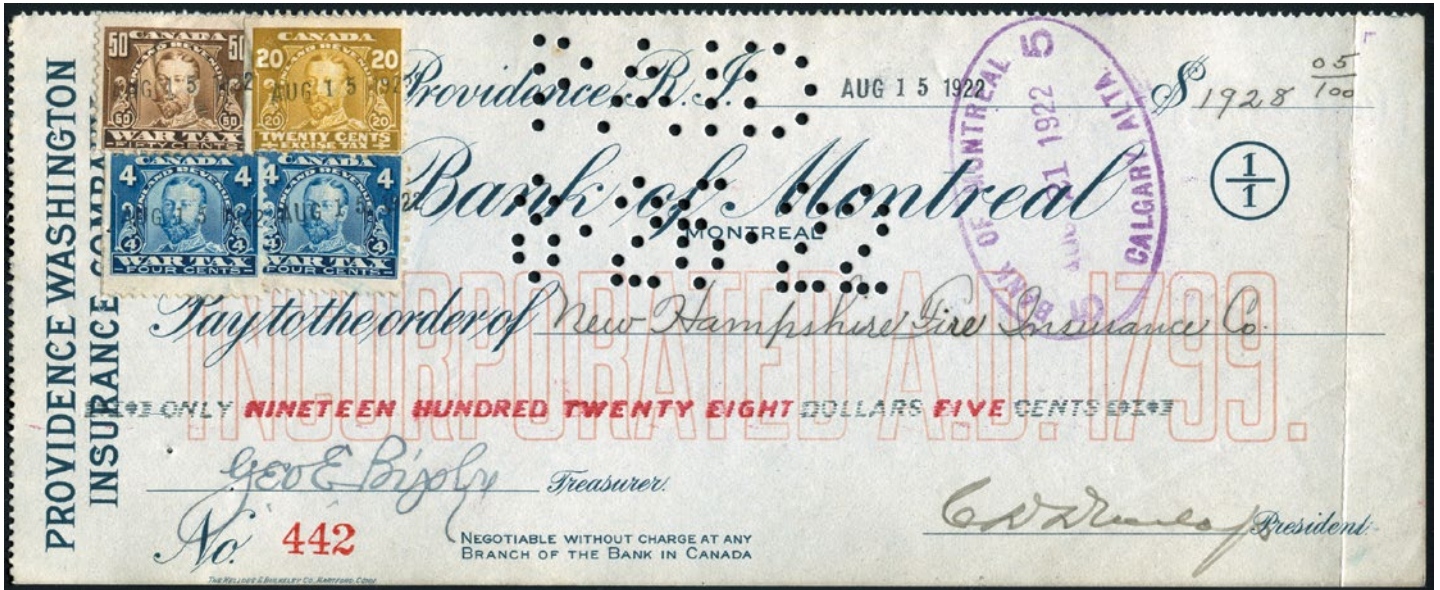

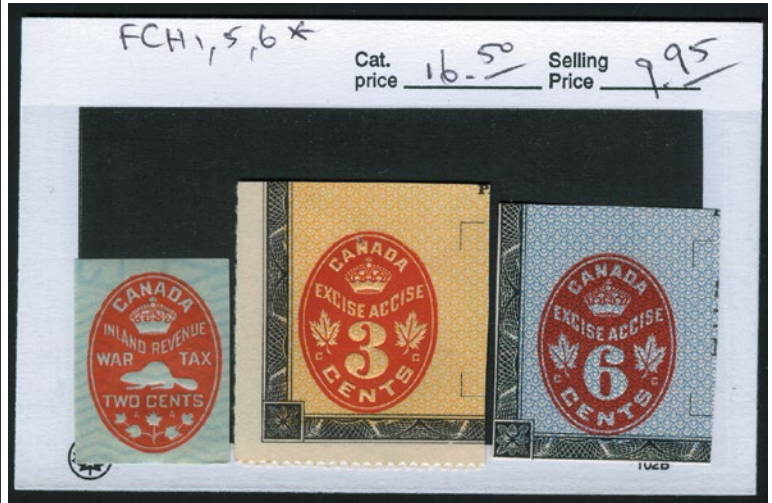

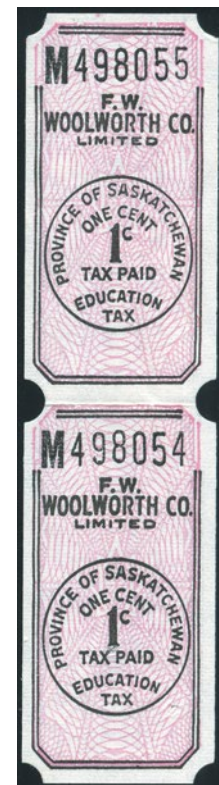
